Dear Sir,

With reference to your application dated 22.3.1976, I am to convey sanction for provisional affiliation of the abovesaid school under the All-India Secondary School Course (classes IX and X) under 10+2 pattern of education w.e.f. 1.8.1976 to 30.4.1978, according to the syllabus/course prescribed by the Board. Sanction is also accorded for the teaching of the work experience subjects (i) Electric Gadgets, their servicing and maintenance and (ii) Tailoring and Embroidery for the same period.

The sanction is subject to the fulfilment of the conditions as have already been laid down or may be laid down by the Board from time to time and is further subject to approval of the Governing Body of the Board.

Sanction in the work experience subjects is accorded subject to the fulfilment of following conditions:-

1. That the qualified staff is appointed for the above mentioned subjects.
2. That proper workshops are set up and adequately equipped, as per requirements of the Board.
3. That adequate number of books are made available in the school library for these subjects.

1. An up-to-date staff-statement in respect of Secondary department (classes IX and X) of the school may please be sent by July, 1976 as per proforma enclosed.
2. Total cost of science equipment (laboratory-wise) added/proposed to be added in the science laboratories/workshops of the school be intimated.

3. Total number of books added in the school library, be intimated.
